The restaurant industry, with an annual turnover of ~ INR 4 Lakh Crore is the third largest after retail and insurance in the service segment, providing direct employment to over 7 million Indians.
- 2. We are writing in regard to the **Urgent need for your intervention** to help Restaurant QSR industry regarding School Children Regulation and impact it is going to have on the QSR industry as a whole.
- 3. As per data collation from 5 major QSR brands and the fifty meter clause needs to be deleted else it will impact the employment, infrastructure loss and business loss which amid the current Covid-19 pandemic further hampers the condition. More than 500 QSR stores are expected to fall within 50 metres of Schools. This data is from 5 major QSR players. However, if we go to the rest of the QSRs, this figure may triple in number.
  - No. of stores to be shut =500
  - Jobs loss = 300X40=20000job loss.
  - Business loss =3160crores INR(in 1 year)
