FOOD DELIVERY FROM RESTAURANTS DURING COVID-19 LOCK DOWN

Hon'ble Lt. Governor,

1. Greetings from National Restaurant Association of India. NRAI is the Indian Restaurant Industry's leading Association. Founded in 1982 and headquartered in Delhi, we are the voice of the restaurant industry representing the interests of 5,00,000+ restaurants pan India. The restaurant industry, with an annual turnover of ~ INR 4 Lakh Crore is the third largest after retail and insurance in the service segment, providing direct employment to over 7 million Indians.

2. At the outset we would like to thank the Government for its proactive steps in combating the COVID-19 pandemic, including the latest lock down measures in the entire country. While restaurants are closed for dine in, we appreciate that food delivery has been included in the services that are permitted during the lock down. However, restaurant operators are facing challenges in getting the essential minimum staff for fulfilling such delivery services. In this regard, we request for your help in allowing movement within Delhi, Gurgaon, Noida & adjacent NCR territories for the following:

- Chefs & Cooks.
- Delivery boys/bikes.
- Delivery vehicles to supply stocks including vendors.
- Managers to run the business.
- Accountant/cashier for managing POS.

3. For facilitating the above, it is requested that passes may be issued to the concerned staff for their movement. These process of issuing these passes may be made online in a time bound manner through a simple form, with the pass being downloadable and printable.
